Sir,

Shreyaan Ishaan Educational Society, Hamsa Homoeopathy Medical College, Hospital and Research Centre, Kasheeragar village, Telangana is functional since 2017 and has applied for permission for sanction of UG (BHMS) course with 100 seats and 42 seats for PG course in 07 subjects with 6 seats in Homoeopathic Philosophy, 06 seats in Materia Medica, 6 seats in Repertory, 6 seats in Homoeopathic Pharmacy, 6 seats in Practice of Medicine, 06 seats in Pediatrics, 6 seats in Psychiatry for the academic year 2024-2025. The college has submitted the Part 1 information in which the entire functional profile has been narrated. Medical Assessment and Rating Board has examined the profile of the college as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under the NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfalls as per MSR requirements:

a) Teaching Faculty

- Documents of following doctors are not uploaded which shall be provided: Dr. Kakda Mahesh, Dr. Amsole Sucharithra, Dr. Vonnamatla Hemalatha, Dr. Samboju Sharath Kumar, Dr. Chitram Uma Shankar, Dr. Cheryala Divya Madhuri, Dr. T Solomon Sampath Kumar, Dr. Asha Emima.
- Experience certificate is not uploaded for Dr. shantanu mukharjee, Associate Prof. from the dept. of Pathology.
- 08 guest faculties are available against the requirement of 12.

b) Hospital details

- Case records are not submitted against the direction issued from MARB, IPD and OPD case records (copy of one OP and one IP cases of 1st and last day of every month for the last 6 months) shall be submitted for verification.

c) **Miscellaneous**

- College has not enabled the Aadhar Enabled Biometric Attendance system (AEBAS). This may be enabled within a period of one month.
- Form-16 is submitted but not from traces portal which shall be provided.

Considering the above observations and facilities available, Medical assessment and Rating board has decided to issue **Conditional permission to Shreyaan Ishaan Educational Society, Hamsa Homoeopathy Medical College, Hospital and Research Centre, Kasheeragar village, Telangana for conducting UG (BHMS) course with 100 seats and 42 seats for PG course in 07 subjects with 6 seats in Homoeopathic Philosophy, 06 seats in Materia Medica, 6 seats in Repertory, 6 seats in Homoeopathic Pharmacy, 6 seats in Practice of Medicine, 06 seats in Pediatrics, 6 seats in Psychiatry for the academic year 2024-2025.**

All deficiencies noticed shall be rectified within a period of one month and compliance report shall be submitted for verification.

All admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats and 15% of postgraduate seats of the permitted intake capacity of 100 UG and 42 PG seats shall be treated as All India Quota. The counseling for seats under All India Quota shall be conducted by respective Counseling authority of State/UT Govt as designated by Central Government/NCH and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.


